

### Society for Eczema Studies Postgraduate Thesis Grant

Dear friends,

Greetings from the Society for Eczema Studies.

As shared previously, one of the major stated objectives of the Society for Eczema Studies is to promote research on eczemas in the Indian context. In order to encourage our budding dermatologists to develop interest in research in this field, we had initiated **3 postgraduate thesis grants in the inaugural year. We are pleased to announce the Society for Eczema Studies postgraduate thesis grants 2025 of INR 1,00,000/- each** 

The scope of the grants is for any form of eczema and is not limited to atopic eczema. The grant is intended to defray cost of consumables, laboratory investigations and contingencies. No expenses under non-recurring head like instruments/ equipment and salary for manpower is permitted. Isolated randomized controlled trials are not permitted. If partial funding is being sought from the Society for Eczema Studies and grant from other funder(s) is being applied for, the same may be stated and permission sought. However, please note that the same expense cannot be submitted to more than 1 funding agency for reimbursement.

Applications can be submitted by filling up the accompanying proposal submission form.

Both the applicant (postgraduate) and the Chief Guide should be members of the Society for Eczema studies, as applicable. For more information on how to become member of the Society, please visit <u>https://eczemasociety.net/</u>

Blinded applications will be evaluated by a Jury constituted for this purpose. Preference will be given to projects with direct relevance to study of eczema in Indian context. Novelty and methodology are other important parameters for assessment.

The projects can start and the first instalment of the grant will be transferred whenever the approval of the Institute Ethics Committee is in place. The second instalment will be transferred after successful completion of the thesis, submission of invoices and receipts (and a certificate that the expense is not submitted to other funding agency (ies) for reimbursement) as well as a synopsis of the findings. The findings will have to be presented in the Annual meeting of the Society for Eczema Studies in the year immediately succeeding the year of completion of the thesis. The findings of the study should be communicated for publication in any Pubmed indexed journal within 2 years of completion. The grant from the Society for Eczema Studies has to be acknowledged in the publication with the statement- Source of funding- Postgraduate Thesis Grant from the Society for Eczema Studies (year of approval of grant in bracket).

- 1. Title of thesis
- 2. Whether the thesis is ongoing or yet to start
- 3. If ongoing- mention the probable date of submission of thesis
- 4. If ongoing- mention if you have obtained or planning to obtain grant from another funding agency
- 5. If yet to start- mention probable date of start and completion
- 6. Summary of the proposed research: Maximum of 3 pages (A4) with normal margins. This is to highlight the available evidence, lacunae in available evidence and how you propose to close the gap.
- 7. Brief review of literature- Maximum of 5 pages (A4) with normal margins. Kindly avoid general review of literature. Focus only to the literature that is important to understand the objectives of the current research. At the end, please provide the summary of the existing literature in tabulated format. References should follow Vancouver style and should be complete. Give emphasis to the accuracy of references and their formatting.
- **8. Aims and objectives.** Include only 1 primary objective. There may be none to many secondary objectives. Use the primary objective only for sample size calculation.
- 9. Patients (or materials) and methods- This should be detailed and should include study design, period of study, source of study participants, inclusion and exclusion criteria, enrolment of participants, proper definition of participants allocated to particular groups (if applicable), tools and technics, outcome parameters, etc. For laboratory investigations, mention the name of the equipment that you plan to use and the process that you will follow. These are important indicative sections. You can use any other section that you think relevant for execution of the study.
